The Register Numbers of those candidates who do

not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured **61 (Sixty one)** marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Shortlist, are required to produce Non Creamy Layer Certificate as per G. O (P) No. 46/2007/SC/ST/DD dated 25.08.2007 or G. O (P) No. 117/2008/SC/ST/DD dated 19/12/2008 along with the other documents mentioned above. The candidates belonging to SC/ST included in the Short List should produce two copies of Community Certificates (obtained after 22/03/2005) along with other documents mentioned above. OBC, SC/ST candidates in the main list who fail to produce the required Non Creamy Layer/Community Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. Register numbers of candidates included in the Supplementary Lists of Other Backward Classes, SC/ST will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate/Community Certificate.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked and photocopy of the OMR answer sheet will be issued after the publication of the Ranked List for the post. Detailed instructions will be found in the Ranked List notification for this post.
