The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO (P) No.46/2007/SC/ST/DD dated 25.8.2007 or GO (P) No. 4/08/SC/ST/DD dated 3.1.2008 or GO (P) No.117/2008/SC/ST/DD dated 19/12/2008 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non creamy Layer Certificate.

Departmental candidates should produce a Service Certificate ( in original) from the Head of Office/Department in the form given in Kerala gazette dated 17<sup>th</sup> July 2006 to prove their service. Otherwise the application is liable to be rejected.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts *after publication of the Ranked List* for the post. Detailed instructions will be found in the Ranked List notification for this post.

Copy of the answer scripts of the OMR Test held on 19/04/2007 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List. Candidates whose Register Number are invalidated are advised to refer to Notification No.ER VI A/2164/07/EW dated 24/07/2009.
