The candidates who have secured 50 (Fifty) marks and above are included in the Short List.

The Candidates included in the Short List are required to produce Non Creamy Layer Certificate as per G.O. (P) No:46/2007/SC/ST/DD dated 25.8.2007 along with other documents mentioned above, Those candidates belonging to the group of Sub-castes of Fishermen community as enumerated in Annexure 'B' and 'C' of the G O (P) No.36/2000/SC/ST/DD dated 27.5.2000 will have to produce community certificates which clearly indicate that they belong to the Sub castes of Fishermen Community, when required.
