Note 3: - Candidates whose Register Numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, ie, qualification, date of birth, community and other benefits, if any, to which they are entitled to The Under Secretary III B, (Government Wing (Recruitment), Office of the Kerala Public Service Commission, Pattom Palace P O, Thiruvananthapuram – 695 004 within 15 days from the date of publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

Those candidates who have secured 41 (Forty one) marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Shortlist, who are required to produce Non Creamy Layer Certificate as per G. O (P) No. 46/2007/SC/ST/DD dated 25.08.2007 or G. O (P) No. 4/2008/SC/ST/DD dated 03/01/2008 or G.O (P) No.117/08/SC/ST/DD dated 19/12/2008 shall produce the same along with the other documents as and when called for. Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

Note 4: The 3% reservation to Physically Handicapped persons in Public Services to this post is extended to Orthopaedically Handicapped persons, persons with low vision and persons who are partially Deaf with hearing impaired only (G.O (P) No.119/2005/SWD dated 6/8/05.

The date, time and place of interview will be intimated in due course.

According to the existing procedure revaluation of answer scripts is not allowed. But answer scripts will be rechecked which will be done after the publication of the Ranked List. Application for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose Register numbers are not included in the Ranked List are advised to refer to Notification No.ER VI A/2489/09/GW dated 09/09/2009 for the Register Numbers of invalidated answer scripts and the reasons thereof.

Copy of the answer scripts of the OMR test held on 10.1.2009 will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List.
