The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

The Candidates who have secured 36(Thirty six) marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of candidates under the supplementary lists.

The candidates belonging to the Other Backward Classes, included in the Short List who are required to produce Non-Creamy Layer Certificate as per GO(P) No. 117/2008/SCSTDD dated 19.12.2008 shall produce the same at the time of interview. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of Community and will be considered as open competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate.

The date, time and place of interview will be intimated in due course.

Rechecking of Answer Scripts will not be allowed before publishing the Ranked List.
