The candidates belonging to other Backward classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O (P) No.117/2008/SC/ST DD dated 19/12/2008 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the main list who fail to produce the required Non-Creamy Layer certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates. As regard to such candidates in the Supplementary lists of Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fails to produce the Non-Creamy Layer Certificate.

The place, date and time of Physical Measurement and interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List if the prescribed fee of Rs. 50/- (Rupees Fifty only) is remitted in any one of the Treasuries in the state by Challan under the Head of Account "0051 PSC – 105 State PSC – 99 Examination Fee". Detailed instruction will be published in the Ranked List notification for this post.
