Note: 1. Inclusion of Register Numbers in this list is purely provisional subject to scrutiny and admission of applications on absolute basis. Inclusion of Register Numbers in the Unified Short List does not confer any right on the candidate to be called for Practical Test or for subsequent inclusion in the Ranked list.

2. The Unified Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

3. **Candidates whose register numbers are included in the Unified Short List are directed to send self-attested copies of documents to prove their claims made in the application, i.e. qualification, the date of birth, community and other benefits if any, to which they are entitled to the District Officer, Kerala Public Service Commission, Kowdiar,po, Thiruvananthapuram** with in 15 days from the date of publication of this notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Unified Short List without further notice.

The candidates who have secured 53 (Fifty Three) marks and above are included in the Unified Short List. The required marks have been lowered to the extend necessary in respect of the Reservation candidates keeping in view the requirement of the rules of reservation.

Such candidates who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and consequent consideration in the next stage of selection.

The place, date and time of Practical Test will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked only after the publication of Ranked List if the prescribed fee of Rs. 50/- (Rupees Fifty only) is remitted in any one of the Treasuries in the state by Challan under the Head of Account "0051 PSC – 105 State PSC – 99 Examination Fee". Applications for re-checking of answer script should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or down load and printed in A4 size paper from the Commission's Web site/www.keralapsc.org or photocopied there from. The original Challan receipt for the prescribed fee should be produced with the application for re-checking. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are included or not included in the Short List and Ranked List can apply for re-checking of their answer scripts, with in one month from the date of publication of the Ranked List.

Valid applications for re-checking addressed to the Deputy Secretary-III, Examinations, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram should reach this office within 30 days from the date on which the Ranked List is officially released by the Kerala Public Service Commission. Applications for re-checking received after the prescribed time limit or not in the prescribed form will not be entertained.

The Fee once remitted will not be refunded.

In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original Challan receipt as stated above, the marks awarded will be re-checked and the result of the re-checking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR Answer Sheet (Part A & Part B) relating to this selection shall remit the fees of Rs.200/- in any of the Treasuries in State (Head of Account '0051 PSC -800 Other receipts – 99 other receipts). The duly filled in application in the prescribed form available from the commission website along with the original chalan should be submitted to Deputy Secretary III (Examination), Kerala Public Service Commission, Pattom, Thiruvananthapuram with in one month from the date of publication of the Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR Sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
