According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List notification for the post.

Application for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose Register numbers are not included in the Short List are advised to refer Notification No. ER VII(A)/1732/09/EW dated 4.12.2009 for the Register numbers of invalidated answer scripts and the reasons thereof.
