ADDENDUM NOTIFICATION

Sub:- B.D.O-Rural Development Department- Modification
of Short List- regarding.

Ref:- S/L No.65/2010/ERXIII dated 08.09.2010.

It is hereby notified that the Short List No.65/2010/ERXIII dated 08.09.2010 for selection to the post of Block Development Officer in rural Development Department (category No.62/2007) published in the Gazette dated 26.02.2007 is modified as follows :

- (i) The head line 'Hindu Nadar' is added under Supplementary Lists.
- (ii) The head line 'SIUC Nadar/AI' referred to under Supplementary Lists is substituted by the head line 'SIUC Nadar'. The Register Numbers 892,958,964 included in the Supplementary List of SIUC Nadar/AI are retained in the Supplementary List of SIUC Nadar. The Register Numbers 575,991 included in the Supplementary List of SIUC Nadar/AI are deleted and the same are included in the Supplementary List of Hindu Nadar.
- (iii) The head line 'LC' under Supplementary Lists is substituted by the head line LC/AI. The Register Numbers of candidates included in the Supplementary List of LC are included in the Supplementary List of LC/AI.
- (iv) The Register Numbers 3223 and 807 (PH) are deleted from the Supplementary List of OBC and the same are included in the Supplementary List of Hindu Nadar and LC/AI respectively.
- (v) The Register Numbers 557 and 631 are added in the Supplementary List of Hindu Nadar.
- (vi) The Register Numbers 867 and 3666 are added in the supplementary List of SIUC Nadar.
