The candidates belonging to Other Backward Classes included in the Probable Short List, who are required to produce Non Creamy Layer Certificate as per G.O (P) No.117/2008/SC/ST DD dated 19.12.2008 shall produce the same at the time of certificate verification. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

The candidates belonging to SC/ST included in the Short List shall produce the Community Certificate dated 20.11.08 or obtained after, from not below the rank of Tahasildar should be produced.

The candidates whose Register Numbers are included in the Short List are required to produce all original documents to prove their educational qualifications and date of birth and community at Kerala Public Service Commission District Office Idukki, Kattappana.

The date, time and place of certificate verification will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is allowed only after the publication of the Ranked List.
