19/12/2008 along with the other documents. The candidates belonging to SC/ST should produce two copies of Community Certificates obtained from the Revenue Authority clearly indicating that the same has been issued to produce before Kerala Public Service Commission. Backward Communities and SC/ST candidates in the main list who fail to produce the required Non Creamy Layer/Community Certificate will not be entitled to the benefit of communal reservation and will be considered as Open Competition candidates. Register numbers of candidates included in the Supplementary List of backward classes, SC/ST will be deleted from the Probability List without further notice, if they fail to produce the Non Creamy Layer Certificate/Community Certificate.

4) The candidates who have secured **58 (fifty-eight)** marks and above are included in the Main list of this Probability List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked and photocopy of the OMR answer sheet will be issued only after the publication of Ranked List. Detailed instructions will be found in the Ranked list notification for this post.
