The candidates belonging to SC/ST should produce two copies of community certificate obtained from the Revenue Authority clearly indicating that the same has been issued to produce before Kerala Public Service Commission Candidates eligible for communal reservation including SC/ST in the main list who fail to produce the required Non Creamy Layer Certificate/Community Certificate will not be entitled to the benefit of communal reservation and will be considered as open competition candidates. Register numbers of candidates included in the Supplementary List of Backward Classes, SC/ST will be deleted from the Probability List without further notice, if they fail to produce Non Creamy Layer Certificate/Community Certificate.

The candidates who have secured 45 (fortyfive) marks and above are included in the Main List of this Probability List. The requisite marks have been lowered to the extent necessary in respect of the supplementary list.

There is no revaluation of answer scripts according to the existing procedure. But answer scripts will be rechecked and photocopy of the OMR answer script will be issued after the publication of Ranked List.
