1. Age & Date of Birth- SSLC/Equivalent Certificate
2. Educational Qualification

- (i) Pass in PDC in Sceince subject or its equivalent

- (ii) B.Sc MLT/Diploma in MLT conducted by the Medical Colleges or Universities in the State or equivalent qualification- originals and self attested copies.

3.Community and caste

SC/ST candidates should produce community certificate (Two Self attested Copies and original) obtained from the Tahasildar and candidates belonging to other backward communities must produce Non Creamy Layer Certificate as per G.O (P) No.117/2008 SC/ST DD dated 19/12/08 (Copy and original)

4. Service Candidates: No Objection Certificate obtained from Head or Office or Head of Department.
5. If there is change in Name, date of birth, community or signature such candidates should produce Gazette notification to prove it.
6. For age relaxation, those who are in provisional service should produce a Certificate showing the period of their provisional service in the concern clearly specifying that they were not working in the regular service of the concern.
7. NCLC and Caste Certificate including name of father may be produced in the same address as noted in the application.
