The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The Candidates who have secured **32 (Thirty-two) marks** and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the candidates included in the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition Candidates.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List if the prescribed fee of Rs.50/- (Rupees fifty only) is remitted in any one of the treasuries in the State by chalan under the ***Head of Account " 0051 PSC - 105 State PSC 99 Examination Fee"***. Applications for rechecking should be submitted within one month from the date of publication of the Ranked List in the prescribed form, available free of cost from the enquiry sections of the various

offices of the Commission or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.org](http://www.keralapsc.org) or photocopied therefrom.

Valid applications for rechecking addressed to the **District Officer, KPSC.District Office, Civil Station, Kozhikode - 20** should reach in this office within **30 days** from the date on which Ranked List is officially released by the Kerala Public Service Commission. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates.

Candidates who wish to obtain the photocopy of their OMR answer Script (part A & B) relating to this selection should remit the prescribed fee of Rs. 200/- in any of the treasuries in the state under the Head of Account. **“ 0051 - PSC - 800 Other Receipts - 99 - Other receipts ”** The duly filled in application in the prescribed form (available from the Commission's Website [www.keralapsc.org](http://www.keralapsc.org)) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Civil Station, Kozhikode - 20** with in one month of the date of publication of this Ranked List. A copy of an answer script will be issued only once to a candidate. Copies of OMR Sheets invalidated due to any defects will not be issued. Candidates are prohibited from applying for a copy of an answerscript which is not their own, and legal proceedings will be initiated against these who do so.
