SC/ST candidates included in the Short List are required to produce 2 copies of Community Certificate issued by the Revenue Authorities, for producing before the Public Service Commission. The candidates belonging to Other Backward Classes included in the Short List, are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/ST/DD dated 26.09.2009. They shall produce the same, along with the other documents mentioned above, as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists, their Register Numbers will be deleted from the Short List without further notice.

The date, time and place of Practical Test will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts ***after approval of the Ranked List for the post.*** Detailed instructions will be found in the Ranked List notification for this post.

Photocopy of the answer scripts of the OMR Test held on 09.07.2009 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
