The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured 63 (Sixty Three) marks and above are included in the Main List of the Short List. The required marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to other Backward classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O (P) No.81/09/SC/ST DD dated 26/09/2009 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates. As regard to such candidates in the Supplementary lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate.

The place, date and time of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked and Photocopy of the Answer Scripts will be issued only after the publication of Ranked List .

Candidates who wish to obtain a photocopy of their OMR Answer Sheet (Part A & Part B) relating to this selection shall remit the fees of Rs.200/- in any of the Treasuries in State (Head of Account '0051 PSC -800 Other receipts – 99 other receipts). The duly filled in application in the prescribed form available from the commission website along with the original chalan should be submitted to Deputy Secretary III (Examination), Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month from the date of publication of the Ranked List. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR Sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
