Such candidates in the Main List who fail to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists, their Register Numbers will be deleted from the Short List without further notice.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts **after approval of the Ranked List** by the Commission. Detailed instructions will be found in the Ranked List notification for this post.

Photocopy of the answer scripts of the OMR Test held on 15.05.2010 will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
