The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO (P) No. 117/08/SC/ST/DD dated 19.12.2008 shall produce the same and candidates belonging to SC/ST communities should produce Community Certificates from the Revenue authorities, along with other documents as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate/Community Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate/Community Certificate.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked ***only after publication of Ranked List.***

Copy of the answer scripts of the OMR Test held on 10.01.2009 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.

Inclusion of Register Numbers 660, 1880,1890,2334, 3698 & 4407 (Main List) 2857 (Supplementary-ST), 628, 1383 (Supplementary-Muslim), 796, 3289, 4622 (Supplementary-OBC), 3215 (Supplementary-O.X) in the Short List is provisional and will be subject to the final judgement of the Honourable High Court in the WP(c) No. 28144/09, 29672/09 and 31585/09.
