The candidates who have secured **53 (Fifty Three) marks** and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary List for ST Candidates.

The place, date and time of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of the Ranked List, if applied as per rules. Copy of the answer scripts will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List. Detailed instructions in this regard will be given in the Ranked List Notification for this post.
