SC/ST candidates included in the Short List are required to produce 2 copies of Community Certificate issued for producing before Public Service Commission.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO (P) No. 117/08/SC/ST/DD dated 19.12.2008/ GO(P)No.81/09/SCSTDD dated 26.09.2009/ GO(P)13232/F3/09/SCSTDD dated 05.10.2009 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Community Certificate, Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts **after publication of the Ranked List** for the post. Detailed instructions will be found in the Ranked List notification for this post.

Copy of the answer scripts of the OMR Test held on 19.9.2009 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List. Candidates whose Register Number are invalidated are advised to refer to Notification No.ERVIA/6484/09/EW.
