- 5) The candidates belonging to other Backward Classes included in the short List who are required to produce Non-Creamy Layer Certificate as per G.O (P) No.117/2008/SC/ST DD dated 19/12/2008 shall produce the same along with other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates.
