The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.org) along with the original chalan should be submitted to The **District Officer, Kerala Public Service Commission District Office Kakkanad, Ernakulam** within one month of the date of publication of this ranked list. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts **after publication of the Ranked List** for the post. Detailed instruction will be found in the Ranked List notification for this post.
