Service Commission, Pattom Palace P.O., Thiruvananthapuram-695 004 within 15 days from the date of publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured 76 (Seventy Six) marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the supplementary lists.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO(P) No. 46/2007/SC/ST/DD dated 25.8.2007 or GO (P) No. 117/08/SC/ST/DD dated 19.12.2008 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the supplementary lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts *after publication of the Ranked List* for the post. Detailed instructions will be found in the Ranked List notification for this post.

Candidates who wish to obtain a photocopy of their answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the Treasuries in the State (head of Account 0051-PSC-800-other receipts-99 other receipts.) The duly filled up application in the prescribed form(available from the Commission's website) along with the original chalan should be submitted to the

Deputy Secretary (Exam), Kerala Public Service Commission, Pattom, Thiruvananthapuram within one month from the date of publication of the ranked list. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
