Such candidates in the Main List who fail to produce the required Community Certificate, Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts ***after publication of the Ranked List*** for the post. Detailed instructions will be found in the Ranked List notification for this post.
