The candidates belonging to Other Backward Classes who are included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO (P) No.81/09/SCSTDD dated 26.09.2009. They shall produce the same along with the other documents at the time of verification of original documents. Such candidates in the Main list who fail to produce required community certificate, Non creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for rechecking of their answer scripts **after publication of the Ranked List** for the post. Detailed instructions will be found in the Ranked List notification for this post.

Copy of the answer scripts of the OMR Test held on 20.06.2009 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List.
