The candidates belonging to Other Backward Communities, shall produce Non-creamy Layer Certificate as per G.O.(P) No:46/2007/SC/ST/DD, dated, 25.08.2007 to claim their benefits. Such candidates in the Main List who fail to produce the required Non-creamy Layer Certificate or Caste Certificate will not be entitled to the benefits of community reservation and will be treated as open candidates.

Those who fail to produce their certificates on the day fixed for certificate verification, in person will be deleted from the list without further notice.

Since the process of finalisation of the Ranked List is time bound, no time will be granted to any candidate in any circumstances to produce any documents in original or copies. Hence the candidate should give special attention to see that their chances are not lost by their absence for the verification.

The verification of documents of candidates included in the probability list will be conducted on 06.12.2008 at 10.00 a.m. at Kerala Public Service Commission District Office, Alappuzha.

The verification of certificates and arrangements of suitability of Physically Handicapped candidate included in the probability list will be conducted later. The date, time and venue will be intimated personally to the candidate in due course.
