Note 3:- Candidates whose register numbers are included in the short list are directed to send self attested copies of documents to prove their claims made in the application, i.e., qualification, date of birth, community and other benefits, if any to which they are entitled, to the **Regional Officer, Kerala Public Service Commission Regional Office, Thrikkakkara Grama Panchayat Building Complex, Kakkanad, Ernakulam, Pin 682 030** within 15 days from the date of publication of this Notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

Those who have already submitted their documents need not send the same again.

The candidates who have secured **56 (fifty six)** marks and above are included in the Main List of List I of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists and List II

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per GO(P) No.46/2007/SC/STDD dated 25.08.2007 shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice., if they fail to produce the Non Creamy Layer Certificate.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of the Ranked List if the prescribed fee of Rs.50/- (Rupees fifty only) is remitted in any one of the treasuries in the State by chalan under the Head of Account “0051 PSC – 105 – State PSC 99 - Examination Fee”. Application for rechecking should be submitted within one month from the date of publication of Ranked List in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission`s website www.keralapsc.org or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are included in the Ranked List should submit the application for rechecking within one month from the date of publication of the Ranked List.

Valid applications for re-checking addressed to the **Regional Officer, Kerala Public Service Commission Regional Office, Thrikkakkara Grama Panchayat Building Complex, Kakkanad, Ernakulam, Pin 682 030** should reach this office within 30 days from the date on which the notification of Ranked List is officially released by the Kerala Public Service Commission.. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.
