The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per **G. O (P) No. 46/07 SC.ST.DD dated 25.08.2007** shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the main list who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.
