NOTIFICATION

Notes:-01. Inclusion of Register Numbers in this list is purely provisional subject to Scrutiny and admission of applications on absolute basis. Inclusion of Register Number in the Short List does not confer any right on the candidate to be called for interview or for subsequent inclusion in the Ranked List.

02. The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

03. Candidates whose register numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, ie, qualification, date of birth, community and other benefits, if any to which they are entitled to the District Officer, Kerala Public Service Commission, District Office, Thrissur, within 15

days from the date of publication of this Notification. The register numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.

The Candidates who have secured 62 (Sixty two) marks and above are included in the Short List.

The candidates included in the Short List who are required to produce Non-Creamy Layer Certificate as per GO(P)46/2007/SC/STDD dated 25/08/2007 shall produce the same at the time of interview. Such candidates who fail to produce the required Non Creamy Layer Certificate, their register numbers will be deleted from the Short List without further notice.

The date, time and place of Physical measurement and interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked after the publication of the Ranked List, if the prescribed fee of **Rs. 50/- (Rupees fifty only)** is remitted in any one of the treasuries in the state by chalan under the head of account “**0051 PSC – 105 State PSC – 99 Examination Fee**”. Applications for rechecking should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission’s web site www.keralapsc.org or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications of rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are not included in the short list are advised to refer to Notification which will be published shortly for the register numbers of invalidated answer scripts and the reasons thereof. Candidates whose register numbers are not included in the Short List should submit the application for rechecking within one month from the date of publication of the Ranked list. Candidates whose register numbers are included in the Short List may also apply for rechecking within one month from the date of publication of the Ranked List.

Valid applications for rechecking, addressed to the District Officer, Kerala Public Service Commission, District Office, M.G. Road, Thrissur - 4 should reach this office within 30 days from the date on which Ranked list is officially released by the Kerala public Service Commission. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for re-checking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.
