Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as open competition candidates. The candidates belonging to SC/ST communities included in the Short List are required to produce two copies of community certificate from Thahasildar issued after 22.03.05.

The candidates who are included in the Short List published on 15.06.05 will not be called for interview again. All others will be called for interview and the date, time and place of interview will be intimated in due course.

Re-checking of answer scripts will not be allowed before publishing the Ranked List.

The Short List is prepared by implementing the judgement dated 13.07.06 of the Division Bench of the Hon'ble High Court of Kerala in WP(C.)No. 21300/05 subject to the result of review petition filed by the Commission but pending before the Hon'ble Supreme Court.
