Note 3:- Candidates whose Register Numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, i. e., qualification, date of birth, community and other benefits, if any to which they are entitled, to the **Under Secretary III, Government Wing (Recruitment), Office of the Kerala Public Service Commission, Pattom Palace P.O., Thiruvananthapuram – 695 004 within 15** days from the date of publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured 63 (sixty three) marks and above are included in the Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 46/2007/SC/ST DD dated 25.08.2007 shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their register numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.
