publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured **70 (Seventy)** marks and above are included in the List.

The candidates included in the Short List are required to produce Non Creamy Layer Certificate as per **G. O (P) No.46/07/SC/ST/DD Dated 25-08-2007** and the Nativity Certificate along with other documents mentioned above. If they fail to produce the required Non Creamy Layer Certificate, their Register Numbers will be deleted from the Short List without further notice.

The date, time and place of Physical Measurement and Interview will be intimated in due course.

According to the existing procedure, Revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List.
