As regards such candidates in the Supplementary Lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non-Creamy Layer Certificate.

The candidates who have obtained 77 (Seventy seven) marks and above are included in the Main List of the Short List. The requisite marks have been lowered to the extent necessary in respect of the candidates under the Supplementary Lists.

The date, time and place of interview will be intimated in due course.

Rechecking of answer scripts will not be allowed before publishing the Ranked List.
