Note 3:- The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of Ranked List if the prescribed fee of Rs.50/- (Rupees Fifty Only) is remitted in any one of the treasuries in the State by chalan under the head of account “**0051 PSC – 105 State PSC – 99 Examination Fee**”. Applications for rechecking should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the enquiry section of the various offices of the Commission or downloaded and printed in A4 size paper from the Commission’s website www.keralapsc.org or photocopied therefrom. The original chalan receipt for the prescribed fee should be produced with the application for rechecking. Candidates whose register numbers are not included in the Ranked List can also apply for rechecking within one month from the date of publication of the Ranked List.

Valid applications for rechecking addressed to the **Deputy Secretary (Examinations) II, Office of the Kerala Public Service Commission, Pattom Palace P.O., Thiruvananthapuram – 695 004** should reach this office within 30 days from the date on which Ranked List is officially released by the Kerala Public Service Commission. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the re-checking will be intimated to the candidates from this office.
