Such candidates in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates.

According to the existing procedure revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of the Ranked List.
