Notes:-

I) Inclusion of Register Numbers in this list is purely provisional, subject to scrutiny and admission of applications on absolute basis. Inclusion of Register Numbers in the short list does not confer any right on the candidate to be called for interview or for subsequent inclusion in the ranked list.

II) The short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

III) Candidates whose Register Numbers are included in the short list are directed to send self attested copies of documents to prove their claims made in the application i.e. Qualification, date of birth, community and other benefits if any to which they are entitled to, to **The District Officer, Kerala Public Service Commission District Office, Civil Station, Palakkad-678001** within 15 days from the date of publication of this notification. *The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications are found otherwise defective will be deleted from the short list without further notice.*

The candidates who possess the required educational qualifications prescribed for the post and appeared for the Written Test held on 21.10.04 are included in the Main list of this Short List. The Candidates included in the Short list published on 27.05.05, but failed to attend the interview are not included in this shortlist.

The candidates belonging to Other Backward Classes included in the Short List who are required to produce Non-Creamy Layer Certificate as per G.O.(P) No.46/2007/SC/ST/DD dated 25.08.2007 shall produce the same along with the other documents mentioned above or as and when called for. Such candidates in the Main List who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. The candidates belonging to SC/ST communities included in the shortlist are required to produced two copies of community certificates issued by Thahasildar after 22.3.05.

The candidates who are included in the short list published on 27.5.05 will not be called for interview again. All other candidates whose Register Numbers are included in this shortlist will be called for interview. The date time and place of interview will be intimated in due course.

In the case of short lists published on or after 01.01.07, rechecking of answer scripts will not be allowed prior to the publication of the Ranked List. From 01.01.07, when the Ranked List is published, all the candidates including those who are included in the Short List can apply for rechecking of their answerscripts.

According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be rechecked only after the publication of the Ranked List if the prescribed fee of Rs. 50/- (Rupees Fifty only) is remitted in any one of the Treasuries in the state by chalan under the Head of Account "**0051 PSC-105-State PSC-99 Examination Fee**". Applications for rechecking should be submitted within one month from the date of publication of the Ranked List in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or downloaded and printed in A4 size paper from the commission's website www.keralapsc.org or photocopied therefrom. The original chalan receipt for the prescribed fee should be produced with the application for rechecking. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. Candidates whose register numbers are not included in the Ranked List should submit the application for rechecking within one month from the date of publication of Ranked List.

Valid applications for rechecking addressed to **the District Officer, Kerala Public Service Commission District Office, Civil Station, Palakkad - 678001** should reach this office within 30 days from the date on which the notification of Ranked List is officially released by the Kerala Public Service Commission. Applications for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained.

The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded by the examiner for the questions will be rechecked and if it is found that the examiner has omitted to award marks for a question or a sub division of a question, the paper will be got rechecked and the discrepancies rectified. The result of the rechecking will be intimated to the candidates from this Office.

The shortlist is prepared by implementing the judgement dated 13.07.06 of the Division Bench of the Hon'ble High Court of Kerala in WP(C) No.21300/05 subject to the result of review petition filed by the commission but pending before the Hon'ble Supreme court.
