- Note 3: - Candidates whose Register Numbers are included in the Short List are directed to send self attested copies of documents to prove their claims made in the application, i.e. Qualification, date of birth, community and other benefits, if any, to which they are entitled to the Under Secretary, GRI A Section, Office of the Kerala Public Service Commission, Pattom Palace P O, Thiruvananthapuram – 695 004 within 15 days from the date of publication of this Notification. The Register Numbers of those candidates who do not produce the required documents within the prescribed time limit and whose applications and found otherwise defective will be deleted from the Short List without further notice.

The candidates who have secured 60 (Sixty) marks and above are included in Main List of this Short List. The requisite marks have been lowered to the extent necessary in respect of the Supplementary Lists.

The candidates belonging to Other Backward Classes who are included in the Short List are required to produce Non Creamy Layer Certificate as per GO(P) No.46/2007/SC/ST DD Dated 25.8.2007 or GO(P) No.4/2008/SC/ST DD Dated 3.1.2008 shall produce the same along with the other documents mentioned above. Such candidates in the Main List who failed to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition candidates. As regards such candidates in the Supplementary Lists of Other Backward Classes, their Register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non Creamy Layer Certificate.

The date, time and place of Interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts will be rechecked **only after the publication of the Ranked List.**
