NOTIFICATION

The candidates who have secured 5 (Five) marks and above in the Written Test are included in the Main List of this Short List. Candidates who were already interviewed and included in the Ranked List published on 29-12-2005 will not be called for interview. The date time and venue fixed for interview will be intimated in due course.

Notes 1. Inclusion of register numbers in this list is purely provisional subject to the absolute scrutiny and admission of applications. Inclusion in the Short List does not confer any right on the candidate to be called for interview and subsequent inclusion in the Ranked List.

2. The Short List is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

3. Candidates included in the Short List are directed to send Self Attested copies of documents to prove their claims made in the application, i.e., Date of Birth, Community & Other benefits if any, they are entitled to the District Officer, K.P.S.C District Office, Kasaragod within 15 days from the date of publication of this Notification. The Register Number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short List without further notice.

The candidates belonging to Other Backward Classes included in this list, who are required to produce Non Creamy Layer Certificate as per G.O (P) No.46/2007/SC/ST DD dated 25.08.2007 shall produce the same at the time of verification of documents. Those in the Main List who fail to produce the required Non Creamy Layer Certificate will not be entitled to the benefit of community and will be considered as Open Competition candidates if they are otherwise qualified.

No rechecking of answer scripts will be allowed as chance for rechecking has already been granted after the publication of the Previous Short List on 31-05-2005.
